**A RESOLUTION ADOPTING THE NATIONAL NEWBORN SCREENING SYSTEM IN THE CITY OF LAS PIÑAS AND SUPPORTING THE PARTICIPATION OF THE LAS PIÑAS CITY LYING-IN CENTER AND THE CITY HEALTH OFFICE IN THE SAID HEALTH PROGRAM.**

**WHEREAS**, Administrative Order No. 1-A Series of 2000 provides that all government and private hospitals must participate in the implementation of the Newborn Screening Program by the year 2004;

**WHEREAS**, on February 7, 2001, the Department of Health issued Department Order No. 29-C, Series of 2001 concerning the creation of a National Technical Working Group on Newborn Screening Program under the National Center for Disease Prevention and Control;

**WHEREAS**, on December 09, 2003, Administrative Order No. 121, Series of 2003 was issued to strengthen the implementation of the National Newborn Screening System;

**WHEREAS**, newborn screening enables early detection and management of certain metabolic disorders, which if left untreated, may lead to mental retardation, serious health complications or death;

**WHEREAS**, newborn screening will ensure that all Filipino children will have access to, and avail themselves of total quality care for their optimal growth and development to their full potential;

**WHEREAS**, the City Government is cognizant of the importance and essence of this public health strategy, assuring a newborn's right to live and safeguarding his/her full potential;

**NOW, THEREFORE:**

**BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Las Piñas, in session assembled, to adopt, as it hereby adopts the National Newborn Screening System in the City of Las Piñas;
